Mr. Kinroth has served as the St. Louis Metropolitan Area Regional Manager for Seagull Environmental Technologies, Inc., since 2001. He uses over 19 years of combined academic and on-the-job training in analytical chemistry, biology, and field methods/procedures to conduct investigations/assessments at Superfund hazardous waste sites, assist in analytical troubleshooting, and provide solutions to analytical problems. He applies integrated site assessment procedures to incorporate informational and programmatic requirements of various federal and state agencies. He prepares and implements quality assurance project plans (QAPP), sample analysis plans, and site-specific health and safety plans (HASP). He conducts emergency responses to releases of hazardous substances, provides oversight of CERCLA removal actions, manages Removal Site Evaluations (RSE), Preliminary Assessments (PA), Site Inspections (SI), and Expanded Site Inspections (ESI), including preparation of preliminary Hazard Ranking System (HRS) scoring packages, which assess threats posed by hazardous waste sites to human health and the environment.

Since 2006, Mr. Kinroth has served as the Hazardous Waste Specialist and a principal project manager for the EPA Region 7 Superfund Technical Assessment and Response Team (START) III contract. He is responsible for issues related to proper handling/disposal of hazardous wastes, including coordination and interpretation of appropriate waste profile analyses. From 2000 to 2005, he served as a senior emergency responder and project manager for the EPA Region 7 START II contract. From 1996 to 2000, he served as the Assistant Program Manager for the U.S. EPA Region 7 START I contract. From 1989 to 1996, Mr. Kinroth was a project manager and the Assistant Leader for the former EPA Region 7 Technical Assistance Team (TAT) contract. The combined value of these contracts is approximately \$150 million.

Mr. Kinroth has responded and participated in more than 200 emergency responses and natural disasters; managed more than 200 complex assessments at hazardous waste sites, many of which were conducted simultaneously; and provided oversight of approximately 100 removal activities at Superfund sites. He has prepared, reviewed, and implemented QAPPs, sampling plans, air monitoring plans, and HASPs at hundreds of hazardous waste sites; and prepared deliverables for numerous removal actions, removal site evaluations, preliminary assessments, and site inspections to ensure compliance with EPA guidance and procedures.

Mr. Kinroth has managed the Missouri Homeland Security Assessment and Strategy contract, which Seagull Environmental Technologies, Inc. was a subcontractor. Under this contract, Mr. Kinroth conducted organizational meetings with jurisdictions within the eastern zone of Missouri; collected data relevant to threat vulnerability assessment, preparedness, and capacity; and developed a statewide strategy to protect critical infrastructure assets. In addition, he prepared emergency response annexes for the State of Missouri Emergency Management Agency.
